

SMESA Legal Awareness Workshop

No one knows when one could lose mental capacity. We have read or perhaps know of cases where a person's welfare was put at risk when the person's mental capacity is affected. Pre-planning for such an eventuality, which could be completely unexpected, is important.

A Lasting Power of Attorney (LPA) is a legal document that allows a person, aged 21 years and above (the Donor) to appoint one or more trusted persons (Donees) to make decisions and act on the Donor's behalf if and when the Donor lacks mental capacity in the future. The Donor decides on the power to be granted to the Donees. This could be on personal affairs only, property affairs only or both personal and property affairs. Where specific or customised powers are to be conferred to the Donees, a lawyer will be required to draft the requirements.

As we are being encouraged to seriously consider drawing up a LPA, SMESA Legal Awareness Committee organised a 2-day workshop for members of the St Margaret's Family (SMESA, the Schools, PTA, PSG and the School Chaplaincies). As a further encouragement, the Government has extended the waiver of registration fee for Singapore Citizens to 31 March 2026.

Families and friends of members of the Family were also invited to the workshop. Besides learning more about LPA, the workshop was planned participants to help our appointment of their Donees through to submission to the Office of Public Guardian (OPG) as required under MSF regulations. The workshop was led by SMESA Member Ms Ruby Lee, Deputy Director at SMS Pro Bono Centre, supported by students from SMU.

Part 1 of the workshop on 3 June was a talk on mental health and how we can be prepared for any unfortunate event affecting our ability to take care of ourselves.



SMS(P) – PERI-Upgrading Project Updates

Construction Status

The journey for SMS(P)'s school building upgrading project has been an eventful one. The School started its Primary Education Review and Implementation (PERI) Upgrading Project in 2020 after the tender was called in 2019. It had to come to a halt amid the Covid pandemic.



By May of the year, the Ministry of Education (MOE) together with the School announced to its stakeholders that the initial plan to complete the project by December 2021 was now delayed by one year. This was in alignment with the many construction projects nationwide as manpower supply (mostly foreign workers) was greatly impacted with travel restrictions. The disruption created a further delay when the main contractor fell prey to financial adversity during the pandemic.

The new contractor was subsequently engaged and the School was scheduled to start operations at its permanent site at 136 Sophia Road in January 2024 upon the completion of upgrading works by December 2023. However, the prolonged wet weather conditions from end 2022 to early 2023 had delayed the works on the permanent site. The wet conditions had slowed down the progress of the upgrading work as extra precautions and measures needed to be taken before continuing any structural work at the site.

Due to this delay, the school will continue to operate from the current holding campus at 2 Mattar Road until December 2024 and commence the new academic year in January 2025 at its upgraded campus. In April 2023, the School communicated this change to the board members of the School Management Council, staff, students, parents and stakeholders.

Construction Cost

The cost of construction had also increased several folds following the need to engage the new contractor in the midst of the pandemic. It had escalated with the supply chains dented by severe shortages of raw materials and manpower.

Even with the various MOE grants accorded, the School still has to raise at least S\$3.1 million, being its share to cover the construction cost. More fund is required to finance the different facilities as well as to provide for stringent security and safety related measures.

During the Covid years, the plans to organise big events for fund raising were hampered as the government authorities were strict with safe management measures like safe distancing and crowd control. Post Covid saw a different concern. Given the current global economic uncertainties, reaching out to corporations for big sum donations can be a challenge.

Not to be discouraged and with faith in God's provision, students and staff explored alternatives and are paying forward - planning events like concert performances, sports jamboree and sales of souvenirs to contribute to the building fund. The support from the alumni and parents also contributed to the efforts.

By God's grace, we have passed the midway mark in our fundraising efforts and will continue to appeal to everyone's generosity to make a donation to the School Building Fund. Any possibility of financial support from any source or advice would continue to be appreciated.
